1. All equipment shall be offered on an "as-is, where-is" basis without warranty or guarantee of suitability or fitness for the purpose for which it was intended.
2. City of Warden reserves the right to refuse any and all bids and the right to withdraw any items from the sale without prior notice.
3. Bidders receiving multiple awards shall purchase all equipment awarded to them. Bidders failing to pay for all items awarded shall have their bid proposals rejected for all auction items.
4. Bid results will be available at 2:00 p.m. on (Friday, February 19, 2016). The City will attempt to contact the successful bidder until 5:00 p.m. on Monday, (February 22, 2016), using the contact information on the bid proposal form. If the highest bidder cannot be contacted, the award will go to the next highest bidder. Also, bid results can be obtained by calling (509) 349-2326.
5. After the City has sold a piece of equipment, it becomes the sole responsibility of the Buyer.
6. **PAYMENTS MUST BE IN THE FORM OF CASH, MONEY ORDER OR CASHIER'S CHECK MADE PAYABLE TO THE CITY OF WARDEN.**
7. No equipment will be released and no titles issued until payment in the form of cash, money order, or cashier's check has been made in full. **Payments to be made at City Hall.**
8. Buyer shall provide receipt of payment at time equipment is removed from City property.
9. All equipment must be paid and removed from City property by 3p.m. on February 29, 2016. Pick up hours are Monday – Friday 9:00 a.m. to 3:00 p.m.
10. It is the Buyer's responsibility to provide proper safety devices and equipment, licenses, and permits necessary to meet all government safety standards and legal driving requirements.
11. Buyer agrees to indemnify and hold harmless Seller against damage caused by the acts of Buyer or any person acting at Buyer's request or on Buyer's behalf in connection with the dismantling or removal of property.
12. Vehicles sold do not have license plates. License plates and title transfer may be secured from a Washington State Vehicle Licensing Office. Three-day driving permits are available for purchase at state license agencies. **It is Buyer's responsibility to pay sales tax at the licensing office.**
13. Federal Law requires odometer disclosure at the time of transfer of vehicle ownership. No titles will be released prior to the completion of an Odometer Disclosure Statement. (Exception: Vehicles ten years and older do not require an odometer disclosure).
